

Dear Sculptor,

The 2 Rivers Art Project Committee, Glenwood Springs Center for the Arts and The Glenwood Springs Chamber Resort Association invite you to submit artwork to be considered for our 2012/2013, year-long, public exhibit: 2 Rivers Art Project (2RAP) in Glenwood Springs. We're looking for high-quality sculpture for this display. It has been a long time dream to create a strong public art program for the City of Glenwood Springs. This is our fifth year presenting public art in the community.

The exhibit is open to professional and amateur artists of all backgrounds. Each artist may enter up to four works. There are no limitations on the dimensions. A selection committee will review all entries and choose up to 3 pieces based on the originality of the piece, its durability and suitability for outdoors and safety for the public. Artists, upon acceptance into the year long display, must be able to deliver their works by May 24/25, 2012 to the designated installation site.

The pieces chosen for the exhibit will be available for sale. Any pieces that are not purchased are to be returned to the artist's possession.

In the event that a piece is purchased during the exhibit year, the purchaser will be asked to leave it in the exhibit until the next sculpture change. In the rare instance that the purchaser must take the piece before the sculpture change, the artist is offered the opportunity to install a new piece.

If selected, you will be notified by April 6, 2012 and asked to provide us with a high quality electronic image for marketing. To apply, detach and return the completed application and signed agreement by March. 15, 2012.

## RULES & REGULATIONS

1. **Sculptures:** 2 Rivers Art Project is a public project; all works are juried for originality, quality, durability, and appropriateness for public display. Fragile, dangerous, and inappropriate works will not be accepted. You may submit four entries.
2. **Stipend:** Chosen Artists will receive a \$500 stipend.
3. **Commissions:** 2RAP will retain a 25% Commission for any artwork purchased during the exhibit period or as a direct result of this exhibit.
4. **Agreement:** All artists must sign an exhibit agreement form and include with the application. Please include an artist bio.
5. **Entries:** Entries may not be removed before the end of the exhibit unless special arrangements have been made prior to the removal of the piece.
6. **PLEASE:** Follow all directions on the exhibit entry forms. Please meet all deadlines.

## A Juried Sculpture Event

### 2 RIVERS ART PROJECT - EXHIBIT AGREEMENT

This is an agreement between 2 Rivers Art Project (2RAP) and \_\_\_\_\_ (artist)

concerning display of sculpture during the 2012/2013 exhibit. The artist certifies that his/her artwork is original and available for purchase. The artist certifies that works are soundly and professionally constructed of durable and sturdy materials, have no breakable or easily damaged parts or pieces, are suitable for outdoor public display, are constructed in a way which will not cause safety or liability problems, and will require no maintenance during the twelve month exhibit period. The artist is responsible for securely attaching works to a durable steel base or mounting plate in order for the piece to be welded to a metal pedestal or, if over six feet in height, bolted to the sidewalk. The artist is responsible for the integrity and workmanship of the piece, its parts, and its attachment to the mounting plate. 2RAP is responsible for securely installing all artwork and maintaining catastrophic insurance coverage on all works only in the event of vandalism, theft, or damage by motor vehicles. 2RAP reserves the right to make all installation/placement decisions and to make emergency repairs to works when necessary. 2RAP will make a reasonable effort to market works exhibited and will produce and distribute informational materials that may feature said sculpture(s). The artist agrees that 2RAP will handle all sales and that 2RAP will retain a 25% commission for any artwork purchased during the exhibit period or as a direct result of this exhibit. The artist agrees to deliver the sculpture(s) for installation to Glenwood Springs by, May 24/25, 2012. All works are committed to 2RAP for the duration of the exhibit (approximately one year).
